The January 9, 2017 meeting of the Hawaiian Philatelic Society was called to order at 7:30pm. There were five members present. The following items were considered during the business meeting. The Treasurer reported that the current cash flow is positive, and the HPS financial health is good. Mr. Coiner and Mr. Gale will switch positions on the 2017 executive board. Mr. Coiner will be the Treasurer and Mr. Gale the Auctioneer. The February HPS Bulletin and auction are being prepared and should be mailed and emailed to members the week of 15 February. The July 2016 files of Po'Oleka were forwarded by Mr. Chang and production should begin within the week. On December 23, nineteen items were submitted for expertization, and by January 6, all had been completed/mailed to members. Under old business, participation by HPS at WESTPEX was discussed. Several members from Hawaii are planning to attend and help with an HPS information booth and informal event. Also, access to HPS materials held by Mr. Kay Hoke was mentioned, but discussion was deferred until the February executive board meeting. The only new business item was the preparation of a cached first day cover for the Queen Lili'uokalani Gardens \$6.65 stamp to be issued by USPS in 2017 (see below). Further information is needed. The business meeting was adjourned at 8:00pm and was followed by the January called auction.

Lili'uokalani Gardens (Priority Mail)

This Priority Mail stamp is being issued to coincide with the 100th anniversary of Lili'uokalani Gardens in Hilo, Hawai'i. Built on land donated by Queen Lili'uokalani (1838–1917), the last Hawaiian monarch to govern the islands, the gardens were dedicated in 1917 and named in her honor. Hilo's Lili'uokalani Gardens are Japanese in style with influences of Hawaiian remains of lava flows, plantings of tropical trees and flowers, and a view of the Mauna Kea volcano — Hawai'i's highest point. The stamp art features one of the gardens' most iconic structures, the red wooden shelter on a stone bridge spanning a portion of the pond. The bridge is surrounded by three stone lanterns and lush tropical plants. Art director Greg Breeding designed the stamp with original art by Dan Cosgrove. (USPS Press Release, December 28, 2016)
